#### 1. Introduction

When emailing us from this website we may keep your personal details on file to provide you with further information requested and to respond to your queries.

It is important that the personal information we hold about you is accurate and current. Please keep us informed by contacting us if your personal information changes during the period which we hold your data.

#### **Market Research**

If you have indicated that you want to receive invitations to participate in market research, we will use your contact data for the purposes of:

- inviting you to take part in market research activities relevant to your specialty and seniority; and
- monitoring and enabling your participation in market research activities via our website, to ensure that you can only participate in the same activity once and that any incentives offered for taking part in such activities are correctly credited to you.

This use of your data involves an element of profiling and automated decision making, in that we screen our respondents (using automated means) on the basis of their specialty and seniority so that only respondents falling within the specialty and seniority criteria specified by our clients for specific market research activities are invited to participate in those activities. This screening process is necessary in order to ensure that our clients are able to comply with their legal obligations under the Association of the British Pharmaceutical Industry (ABPI) code to target market research activities at medical professionals for whom the market research is relevant/suitable according to their specialty and seniority. The legal basis for processing your data for market research activities is via your consent to participate. Where incentives are offered in return for taking part, the legal basis for our processing of your account data for the purposes of crediting you with those incentives will be performance of a contract.

## 8. Protection of your data

We are committed to taking all reasonable and appropriate technical and organisational security safeguards to protect the personal data against accidental, unlawful, or unauthorized destruction, loss, alteration, access, disclosure, or use.

#### 11. Visitors to our website

#### Cookies
